On reviewing the income statements, it has been noticed that the financial performance of the company for the period under review is pleasing, particularly considering the reduced level of occupancy at the Permanent Accommodation for Contractors (PAC's) at Fahud and Nimr compared to the previous year.

We are pleased to append below the financial information for six months of current year operations in comparison to corresponding period of last year.
